\* The amount listed for the County Court at Law Judge only reflects the salary paid by Caldwell County. The County Court at Law Judge also receives salary supplements paid by the County but reimbursed by the State of Texas in the amount of \$79,689.00.

\*\* The County Judge and Commissioner Muñoz do not take County Health Insurance. The County Judge also receives a state salary supplement of \$15,000.00 annually for certain judicial functions.

The proposed salaries noted above will be included in the Caldwell County proposed budget which will be voted on in a public meeting to be held at 9:00 a.m., Thursday, August 29<sup>th</sup>, 2013 in the Commissioners Courtroom located at 1403 Blackjack Street, Lockhart, Texas.

Additionally, listed officials may receive a monthly cell phone stipend of between \$35.00 to \$125.00 per month.
